The salient features of the above works are as follows:-

- i) Estimated Cost :- Rs. 1,25,18,160/- Rupees One Crore Twenty five lacs eighteen thousand one hundred sixty
- ii) Earnest Money :- Rs. 20,000/- (Rupees Twenty thousand) only
- iii) Time of Completion: - 8 (eight) months – 240 days.

- 2) Details of partners, in case of partnership firms and details of Board of Directors, in case of a company supported by duly authenticated partnership deed of memorandum and articles of Association as applicable.
- 3) Address of Registered Office, Address of Office in Kolkata if any with Telephone No. & Fax Nos. etc.
- 4) Ownership, Capital structure, financial structure of the construction firms, where applicable.

- 5) A list of works of comparable magnitude and the nature of works successfully completed by the construction firm in the last five years including locations. Cost time of completion, so carried out along with performance certificates issue to them also indicating that these works were completed within contractual time schedule or not and reason thereto. (Copies of work orders and related completion certificate to be attached).
- 6) The list of present commitment (with details as at Sl. No. 5) & percentage of works completed and expected date of completion.
- 7) Technical reference from at least three employers should be given to whom reference may be made about companies, firms technical and organizational liabilities.
- 8) An undertaking whether the firm was blacklisted or not in the past.
- 9) List of construction equipments available for the use of the proposed works.
- 10) List of Experienced Technical personnel with their qualifications, age, experience.
- 11) Extent of availability of designs knowhow.
- 12) Latest valid income tax, sales tax and professional tax clearance certificate, Trade License and Sales Tax Registration Certificate, the PAN of Income Tax Dept. for Company/ Partners/Proprietors.
- 13) Solvency certificate issued by the Banker's of the Firm/Company.
- 14) Financial Capacity and credit facilities available to the Firm/ Company as certified by their Banker (Banker's certificates in original or duly attested).
- 15) Any other relevant information considered necessary to justify eligibility of the applicant.
